Business Coalition against Trafficking

Human Trafficking, a global phenomenon, is a gross violation of human rights and human dignity, which involves the use of force, fraud or coercion to transport, recruit, harbour and force people to provide labour or services against their will.

The **Private Sector**, knowingly or unwittingly, can get entangled in these global trafficking networks, becoming either the "facilitators" or "targets" of human trafficking. However, businesses are also uniquely positioned to prevent the use of exploitative labour practices:

"The private sector has so much to offer in terms of resources, knowledge and influence to combat human trafficking...Businesses have a moral and legal responsibility to ensure that all aspects of their operations are "traffic-free" - from employees, to suppliers, to partners"


Facts on Human Trafficking

- "On any given day in 2016, 24.9 million were in forced labour" Global Estimates, Alliance 8.7 (2017)
- US \$150 billion is the estimated value of global human trafficking 'industry"
 ILO (2012)
- Profits generated by forced economic exploitation by sector (ILO, 2014):
 - US\$ 34 billion in construction, manufacturing, mining and utilities
 - US\$ 9 billion in agriculture, including forestry and fishing
 - US\$ 8 billion saved by private households by not paying or underpaying domestic workers held in forced labour.

In 2017, RESPECT reached out to about 10,000 companies and other stakeholders via <u>a survey</u> to assess the immediate needs of the business community. On that basis, RESPECT and its <u>Resource Centre</u> were designed.

RESPECT Webinar Series
