## **18th ALLIANCE AGAINST TRAFFICKING IN PERSONS Conference**

### **Everyone Has a Role: How to Make a Difference Together**

Vienna, Hofburg (Neuer Saal)

23-24 April 2018

The 2003 OSCE Action Plan to Combat Trafficking in Human Beings and the UN Global Plan of Action to Combat Trafficking in Persons call for effective co-operation at all levels to address what amounts to one of the most far-reaching and lucrative criminal enterprises on the globe and to afford victims the necessary protection which basic decency and human rights demand.

The 18<sup>th</sup> *Alliance against Trafficking in Persons* conference will promote the importance of inclusive partnerships to further enhance the coherence of anti-trafficking efforts and strengthen co-operation at the local, national, regional and international level. It will also provide a forum for participants to examine existing, more traditional anti-trafficking partnerships, along with the benefits of engaging key, yet often omitted actors, such as medical practitioners, teachers, financial investigators, businesses, municipalities, media, community and religious organizations which often remain 'invisible' in formalized multi-disciplinary frameworks. A special emphasis will also be placed on new actors whose engagement would bring added value to anti-trafficking responses. The conference will advocate that a multi-disciplinary approach is crucial in the timely prevention, detection and disruption of the crime of trafficking in human beings, as well as in identifying potential and presumed trafficked cases and ensuring proper referral and assistance.

Throughout the conference, efforts will be made to further promote the full and effective implementation of international instruments and relevant OSCE commitments, including both relevant 2017 Ministerial Council Decisions, namely *Strengthening Efforts to Prevent Trafficking in Human Beings* ([MC.DEC/6/17](#)) and *Strengthening Efforts to Combat All Forms of Child Trafficking, Including for Sexual Exploitation, as well as Other Forms of Sexual Exploitation of Children* ([MC.DEC/7/17](#)).

**Panel 1 – Review of Current Co-operation Mechanisms in Combating Trafficking in Human Beings**

*The first panel will review current co-operation and co-ordination mechanisms and underline the need for complementarity of efforts to better address trafficking in human beings.
