
VINETA POLATSIDE

Corinne Dettmeijer-Vermeulen The Dutch National Rapporteur on Trafficking in Human Beings and Sexual Violence against Children

Mrs. Dettmeijer-Vermeulen's recommendations have led to a doubling of the capacity for the investigation of child pornography and a greater realization that the approach to it must not be confined to investigation and prosecution (Ministry of Security and Justice), but must also extend to prevention and identifying and providing assistance for victims (Ministry of Health, Welfare and Sport). A further development is that there are now also judges specializing in human trafficking cases. On the recommendation of the National Rapporteur, a campaign has also been launched against child sexual abuse. After finishing her law degree at Leiden University, Corinne Dettmeijer started her career



as a public prosecutor in Rotterdam. Corinne Dettmeijer has for many years been a judge at the district court of The Hague, from 1995 until 2014 as vice president of the court. As a judge, she handled cases in juvenile, criminal, family and migration law. She has been a member of several (international) professional bodies and advisory committees in the field of juvenile law. Corinne Dettmeijer is a member of the board of the Pro Juventute Foundation, the European Institute for Crime Prevention and Control, affiliated with the United Nations (HEUNI) and the High-level Global Taskforce to End Sexual Exploitation of Children in Travel and Tourism.

In 2015 and 2016 The Dutch magazine Opzij elected Ms Dettmeijer as one of the most powerful women in the Netherlands working on justice and public policy.

His expertise is in inter-agency cooperation, engagement of unusual partners in Prevention and promotion of new Partnerships with the objective of raising public awareness and 'bringing-in' more stakeholders to tackle the 'demand side' of trafficking (i.e. Private Sector/slavery-free supply chains).

MERCIA SILVIA, Executive Director, the National Pact Institute for the Eradication of Forced Labor (InPACTO), Brazil



Federation of Trade Unions of Maritime Transport Workers, confederation of trade unions, which includes sailors, dockers, and other workers of the maritime industry. In 1995 Mr. Pavlov graduated from the Russian Communication, Finance and Economic Institute as an economist. Mr. Pavlov is married and has has two children

SAMIR GOSWAMI, Senior Advisor, United Way Worldwide, Center on Human Trafficking & Slavery

Mr Goswami is a senior advisor to United Way Worldwide where he helps the Center on Human Trafficking and Slavery engage multinational corporations on counter-trafficking initiatives. He also consults with Mobile Accord Inc. and Issara Institute on developing technology solutions that assist companies in identifying labor and human rights issues in their supply chains. Previously he was the Director of Government Professional Solutions at LexisNexis where he directed a team that managed a \$12 million portfolio of U.S. Government contracts with the Agency for International



Development, State Department, Department of Defense and Intelligence Communities and developed the company's rule of law business line. He also served as Lexis Nexis' Director of Corporate Responsibility where he integrated CSR into business development efforts and created partnerships with government entities, associations and NGOs that have increased access to legal services for thousands across the country. As a Managing Director of the Individuals and Communities at Risk Program at Amnesty International USA, he oversaw a crisis response unit that responded to 500 human rights incidents each year. 
BOB MITCHELL, Vice-President of Social & Environmental Responsibility, EICC

Responsibility at Hewlett Packard Enterprise, leading a team of professionals in human rights, supply chain responsibility and conflict minerals, among other issue areas. Bob also served on the EICC Board of Directors for nearly four years and was Vice Chair in 2016. LAURA GERMINO, Anti-Slavery Program Director, the Coalition of Immokalee Workers

Ms. Germino is an internationally recognized expert on modern-day slavery. She accepted on behalf of CIW the 2015 Presidential Award for Extraordinary Efforts in Combating Human Trafficking, awarded by President Obama. Ms. Germino and her colleagues have uncovered, investigated, and assisted in the prosecution of many multi-state forced labour operations in the agriculture since the early 1990s, including the seminal slavery operation U.S. v. Flores, which helped lead to the initial passage of the Trafficking Victims Protection Act (TVPA) in 2000. A plenary speaker at the White House on eradicating



slavery, she has also participated in the U.S. Department of Health and Human Services' technical

working group on victim services; developed human trafficking investigations curriculum for the Florida Department of Law Enforcement; and trained at the invitation of the OSCE in Vienna, the F.B.I. at Quantico, the U.S. Embassy in Medellin, and the U.S. State Department in Morocco, amongst others. Ms. Germino co-founded the Freedom Network Training Institute (FNTI) on human trafficking, which trains state and federal law enforcement and NGOs on how to identify and eliminate forced labour operations. She is a member of the Durham University (U.K.) Advisory Board for Horizon 2020, the European Union's project to eliminate forced labor in EU supply chains by the year 2020. Her work is featured in the books "Nobodies: Modern American Slave Labour and the Dark Side of the New Global Economy" and "The Slave Next Door". Ms. Germino received a commendation from FBI Director Robert Mueller, the Anti-Slavery Award from Anti-Slavery International of London, and in 2010 was the first U.S. recipient of the State Department's TIP Hero Award from Secretary of State Hillary Clinton for her "perseverance against slavery operations in the U.S. agricultural industry" and "determination to eliminate forced labor in supply chains". As an alumna, she received the John Hope Award for Public Service from Brown University. She has an M.A. in International Economics and Social Change and Development from the Johns Hopkins School for Advanced International Studies (SAIS).



IRENA FERČÍKOVÁ KONEČNÁ,

Ph.D., independent expert and consultant, member of International La Strada Association, leading European NGO-network working to ensure a world without trafficking in human beings by promoting respect for human rights. In 2015, Ms Ferčíková Konečná was awarded Fulbright scholarship and did her research at US based NGO Polaris (formerly Polaris Project) one of the largest anti-trafficking organizations in the US that operates the National Human Trafficking Resource Center NHTRC. From 2008 to 2014 Ms. Irena Ferčíková Konečná was a national coordinator and director of La Strada Czech Republic, non-governmental organization that provides direct assistance to victims of trafficking and aims to contribute towards the elimination of all forms of exploitation and trafficking in human beings. Ms.

Ferčíková Konečná initiated, coordinated and contributed to numerous Europe-wide anti-trafficking projects and researches. Prior to this, she worked as an educational and social program manager of NGO People in Need in Ethiopia (2006-2008) and trained humanitarian assistance workers of Caritas in Sri Lanka (2005). Before joining the non-governmental sector, Irena Ferčíková Konečná worked for the Refugee Facilities Administration of the Ministry of Interior of the Czech Republic from 2003 to 2006, where she coordinated the social work and methodology unit and managed the residential center for asylum seekers and refugees in Stráž pod Ralskem. Irena Ferčíková Konečná had earlier served as lecturer at the Palacky University Olomouc (2001-2003 and 2005-2007). Ms. Ferčíková Konečná completed her Ph.D. in special needs education at the Palacky University, Czech Republic in 2005.



VIKTOROV ANATOLY, Director, Department for Humanitarian Cooperation and Human Rights, Ministry of Foreign Affairs of the Russian Federation
